

## THE GR8 CHASE FOR VICTORY OVER CANCER SWEEPSTAKES OFFICIAL RULES

---

**NO PURCHASE, PAYMENT, OR CONTRIBUTION IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. ODDS OF WINNING DEPEND UPON THE TOTAL NUMBER OF ELIGIBLE ENTRIES. A PURCHASE, PAYMENT, OR CONTRIBUTION TO SPONSOR WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**SPONSOR:** The GR8 CHASE for Victory Over Cancer Sweepstakes (the “Sweepstakes”) is sponsored by and for the benefit of the V Foundation for Cancer Research (“V Foundation” or “Sponsor”), a Section 501(c)(3) tax-exempt organization with its principal place of business at 14600 Weston Parkway, Cary, NC 27513.

**ELIGIBILITY:** Entrants of the Sweepstakes must be eighteen (18) years of age or older and legal residents of the United States (including the District of Columbia). Employees, officers, directors, agents, representatives, and volunteers of Sponsor, the National Hockey League (“NHL”), its member clubs, NHL Enterprises, L.P., NHL Enterprises Canada, L.P., NHL Enterprises B.V. and NHL Interactive CyberEnterprises, LLC (the foregoing NHL entities collectively, the “NHL Entities”), and their respective affiliates, promotional partners, and any other entity directly involved in the development, administration, or execution of the Sweepstakes, and their immediate family members and persons living in the same household, are not eligible to participate in the Sweepstakes. The V Foundation reserves the right to disqualify any entrant for violation of these Official Rules, any applicable laws, or for any misrepresentations related to this Sweepstakes.

**HOW TO ENTER:** Entries for the Sweepstakes will be accepted beginning December 19, 2025, at 12:01 a.m. Eastern Time (ET) and ending on December 31, 2025, at 11:59 p.m. ET (the “Entry Period”). All entries must be received during the Entry Period to be eligible for the Sweepstakes. Entries submitted before or after the stated dates and times will not be accepted.

There are two (2) ways to enter:

- I. **ONLINE (CONTRIBUTION):** To enter by contributing online, visit <https://www.v.org/gr8chase> and make a minimum voluntary donation of fifty dollars (\$50 USD) per entry. Entrants may donate more than \$50 USD per entry if they choose. Online entrants will receive one (1) entry per contribution, regardless of the amount of each contribution. Online entrants may enter the Sweepstakes an unlimited number of times. There will be no physical tickets. Void where prohibited. Online entries must be received by the close of the Entry Period.
- II. **NO PURCHASE, PAYMENT, OR CONTRIBUTION NECESSARY:** To enter without a purchase, payment, or contribution, send a letter stating that you wish to obtain a “no donation” entry with your name, address, phone number and email address to: The GR8 CHASE for VOC c/o the V Foundation, 14600 Weston Parkway, Cary, NC 27513. Only one (1) “no donation” entry per household. “No donation” entry requests must be received at the V Foundation office by 11:59 p.m. ET, on December 31, 2025. An entry without complete information will not be added to a Sweepstakes drawing.

Any use of robotic, repetitive, automatic, programmed, mechanical, script, macro, or any other automated means or similar entry methods or agents (including, but not limited to, contest-entry services or multiple or different email addresses, or the submission of false contact information under multiple or different email addresses, identities, registrations, accounts or logins) or any other devices or artifices to enter or encourage, directly or indirectly, automated or false entries are prohibited. Suspected or detected entry method violations may void some or all entries submitted by that entrant, in Sponsor’s sole discretion.

**SELECTION OF WINNER:** One (1) winner will be selected in a random drawing conducted by the Sponsor at its office in Cary, NC on or about January 9, 2026 at approximately 12:00 p.m. ET from among all eligible entries received during the Entry Period.

The winner will be contacted by email on or about January 9, 2026. The winner must claim the prize within seven (7) calendar days of email notification from the V Foundation or forfeit the prize. If the winner does not claim the prize within seven (7) calendar days, if the prize or prize notification is returned as undeliverable, if the winner is

found to be ineligible, or if the winner does not comply with these Official Rules, the Sponsor may, in its sole discretion, select an alternate winner in a random drawing from the remaining eligible entries.

Winner does not need to be present to win. All entries become the sole property of the V Foundation and will not be returned. The Released Parties (as defined below) are not responsible for lost, stolen, illegible, incomplete, misdirected, late, damaged, destroyed, or delayed entries or postage due mail or for unavailable network connections, failed, incomplete, garbled or delayed computer transmissions, online failures, hardware, software or other technical malfunctions or disturbances or other communications failures or circumstances affecting receipt of entries or entrants' ability to participate in this drawing. A winners list may be obtained by sending a stamped, self-addressed envelope to the V Foundation for Cancer Research, 14600 Weston Parkway, Cary, NC 27513 to be postmarked no later than February 28, 2026.

**PRIZE/ODDS OF WINNING:** One (1) prize winner will be selected at random from the eligible entries received. The winner will receive four (4) lower bowl tickets to either the 3/3/26 or 3/9/26 Washington Capitals game at Capital One Arena, 601 F Street NW, Washington, DC 20004. Winner and three (3) guests will also have food and beverages included. Winner will also receive a jersey autographed by Alexander Ovechkin. Winner and his/her three (3) guests will also participate in a meet-and-greet experience with Alexander Ovechkin at a time, date, and location determined by the Sponsor and/or the Washington Capitals. Failure to claim the prize may result in the forfeit of the prize. Approximate Total Retail Value (ARV) of the prize: \$1,175 USD. The ARV of the prize is based on available information provided to Sponsor, and the value of any prize awarded to winner may be reported for tax purposes as required by law. The odds of winning the Sweepstakes prize depend on the total number of eligible entries received during the Entry Period. There is no limit to the number of entries the Sponsor may receive for the Entry Period.

Winner and three (3) guests, who must also be at least eighteen (18) years old or accompanied by an adult, may be required (or in the case of a guest, his/her parent or legal guardian may be required) to sign a liability waiver and/or publicity release prior to receipt of the prize.

**NO SUBSTITUTIONS; NO CASH REFUNDS, AND NO OTHER CASH SUBSTITUTIONS.** The prize winner assumes and must pay all charges not included above. Winner is solely responsible for all other costs and liability incurred in claiming and using the prize. All unspecified expenses and taxes are winner's sole responsibility. If required, winner will be issued an IRS Form 1099-MISC (or its equivalent) reflecting the ARV of the prize, and he or she will be solely and exclusively responsible for all state, federal or local income taxes that may result from his or her acceptance of the prize. The Sponsor reserves the right at its sole discretion to cancel, terminate, modify or suspend the Sweepstakes. The Sponsor and the NHL Entities make no warranty, guaranty or representation of any kind concerning any prize and disclaim any implied warranty, guaranty or representation.

The Sweepstakes is in no way sponsored or endorsed by the NHL Entities, the NHLPA, or their respective affiliates and subsidiaries.

By entering the Sweepstakes, you expressly agree that (a) except where prohibited by law, any and all disputes and causes of action arising out of or connected with this Sweepstakes, or prize awarded, shall be resolved individually, without resort to any form of class action, and exclusively by final and binding arbitration under the rules of the American Arbitration Association ("AAA") and held at the AAA regional office nearest to you; (b) the Federal Arbitration Act shall govern the interpretation, enforcement and all proceedings at such arbitration; and (c) judgment upon such arbitration award may be entered in any court having jurisdiction.

**SEVERABILITY; WAIVER:** If a court of competent jurisdiction finds any provision of these Official Rules, or their application to a particular person or circumstances, is invalid or unenforceable to any extent, then the remainder of these Official Rules, and the application of all of these Official Rules to other persons or circumstances, shall not be affected by that determination, and shall remain enforceable to the fullest extent permitted by law. The failure of Sponsor to enforce at any time any provision of the Official Rules shall not be considered a waiver of such provision or any other provision.
