18 seconds ago — Jake Paul vs Chavez Jr. fight time: Ring walk time, fight card, prelims and streaming details for US and UK

Influencer-turned-boxer Jake Paul returns to the ring tonight in a much-anticipated bout against former world champion Julio César Chávez Jr., in what is being dubbed the YouTuber's most formidable test yet. Scheduled to take place at the Honda Center in Anaheim, California, the fight is expected to draw global attention as fans gear up for an action-packed night of boxing.



## Jake Paul Fight Time: Ring Walks and Main Event Details

The Jake Paul vs Chávez Jr. bout will headline a loaded card tonight, Saturday, June 28, 2025. The main card starts at 8 p.m. ET on DAZN pay-per-view, with main event ring walks expected around 11 p.m. ET. / 8:00 p.m. PT. For viewers in the United Kingdom, this translates to approximately 4:30 a.m. UK time on Sunday, June 29, as mentioned in a report by Uncrowned.

The showdown will be available on a pay-per-view basis via DAZN, with U.S. users required to pay \$59.99, a price that includes access to DAZN content for seven days. This event comes on the heels of Jake Paul's record-breaking bout last year against Mike Tyson, which drew over 108 million viewers on Netflix, making it the most-streamed sporting event to date.

#### Julio César Chávez Jr: The Comeback Challenge

Chávez Jr., son of Mexican boxing icon Julio César Chávez, brings a professional record of 54 wins, 6 losses, and 1 draw. The 39-year-old last competed in July 2024, securing a decision win over former UFC star Uriah Hall. While once crowned WBC middleweight world champion (2011–2012), Chávez Jr now faces the challenge of re-establishing his credentials at cruiserweight, a class in which Paul has found recent success.

Watch the event live online: The only way to watch Jake Paul vs. Chávez Jr. is on the DAZN streaming service. The Jake Paul vs. Julio César Chávez Jr. fight will not be on any regular local or cable TV broadcasts in the USA. The fight is a pay-per-view only event. The cost of the fight PPV is \$59.99, with bundled fight options available for a higher price. To order the PPV, customers must be signed up for a subscription to DAZN, and there is currently a free trial option available.

Firebrand boxer Jake Paul will try and score a victory over former champion Julio César Chávez Jr. tonight in a stacked boxing match that will be one of the most entertaining sporting events of the weekend. The fighting commences on Saturday, June 28 with a live broadcast on the DAZN streaming service. The undercard fights begin at 5 p.m.

PT/8 p.m. ET, so be sure to buy the fight now if you want to catch it live tonight. What is the actual fight time for the Jake Paul vs. Julio César Chávez Jr match?

The undercard fights begin starting at 5 p.m. PT/8 p.m. ET, so you should purchase the fight package before then to ensure you can get the feed up and working on your TV.

and the main event fight between Jake Paul and Chávez Jr. should begin with ring walks at around 9 p.m. PT/12 p.m. ET. These times are approximate based on how long the undercard fights and ring walks take.

How much does the Paul vs. Chavez pay-per-view cost? What streaming PPV service should I use? A price breakdown:

The only way to watch the fight is by purchasing the PPV through DAZN for 59.99, or by selecting one of the other bundled fight options, like Jake Paul vs Chávez Jr. today AND Usyk vs Dubois II for \$94.99. To watch on DAZN, you can purchase one of their monthly or annual packages, which provide great value for fight fans, or you can sign up for a free trial. Here is information about how you can get DAZN live online or on your TV. Jake Paul is considered the favorite in this fight at (-575) while Chávez Jr. is a (+400) underdog, according to the latest DraftKings Sportsbook odds. The odds of a draw as the result in this fight are considered highly improbable at (+1800).
